## **INDEPENDENT AUDITOR'S REPORT**

**To the Board of Directors of**

**Report on the Audit of the Standalone Financial Results**

### **Opinion**

We have audited the accompanying Statements of financial results of Nidhan Commercial Co. Limited ('the Company') for the quarter and year ended March 31, 2021 ("the statements"), attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations").
